All registrants in the League are subject to the Rules and Regulations of the League. It is the responsibility of each registrant to obtain from the Team Representative(s) or from the Alberta Men's Hockey League website and read the League Rules and Regulations.

Players engage in regular season, exhibition or playoff games at their own risk and "Gladco" will not in any event, be liable for damages for injury or personal loss to any player, howsoever caused. Further "Gladco" will not, in any event, be liable for damages for injury or personal loss to any third party, including spectators, resulting from the actions of the League players on or off the ice surface. All players competing in League Games must execute the Waiver and Release of Liability Agreement.

WAIVER AND RELEASE OF LIABILITY

The undersigned hereby acknowledges having read and understood for foregoing and agrees with same in all respects. Further, in consideration of being allowed to participate in any way in the Alberta Men's Hockey League athletic/sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce the risk, the risk of serious injury does exist: and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASES or others, and assume full responsibility for my participation, and
3. I willingly agree to comply with the stated and customary terms and conditions for participation, if however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately, and
4. I, for myself, and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY FOREVER RELEASE AND HOLD HARMLESS Gladco Enterprises Ltd, and the Alberta Men's Hockey League and their respective officers, officials, agents, and or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct activities ("Releases"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, AND DEATH or loss or damage to person or property, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASES OR OTHERWISE.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

**ARGYLL ICE RINK
COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK
(PLEASE READ CAREFULLY)**

IN CONSIDERATION of permission granted now or in the future by the Owners (as defined below) to participate in the Activities (as defined below) at the Argyll Ice Rink, I agree and acknowledge:

1. In this Agreement:

(a) "the Owners" means collectively 1272978 Alberta LTD., operating as Argyll Plaza Arena, and each of their respective members, officers, directors, employees, independent contractors, agents, partners, associates and affiliates thereof;

(b) "Participating in" means going to, coming from, before, after or during;

(c) "the Activities" include but are not limited to skating, playing organized hockey, wearing skates and equipment associated with hockey and/or skating, occupying the rink area and facility including, but not limited to, the dressing rooms, the team benches, the penalty box, any viewing areas, any common areas and the parking lot; and

(d) Words in the singular form shall be construed to include the plural and vice versa as the context requires.

2. I release the Owners from all liability and waive as against the Owners all recourses, loss or damages, including any consequential damage on loss, claims and causes of action of any kind whatsoever and I voluntary accept the legal risk, thereby expressly giving up any right of action, and the physical risk arising from all liability whether such liability arises in contract, by reason of negligence, or by reason of breach of duty raised by statute, or in any other manner whatsoever.

3. I indemnify and hold harmless the Owners from and against any and all losses, liabilities, claims, demands, causes of action, suits, costs or charges that may be brought against the Owners and all costs and expenses incurred by the Owners (including solicitors fees on a solicitor and his own client basis) of any nature with respect to any injury or disability to me, or in relation to my death, or in relation to any damage or loss of property, to or caused by me, or for which I am legally responsible arising out of my or anyone else undertaking the Activities including any claims, demands, causes of action, suits, costs or charges that may arise out of the NEGLIGENCE OR FAULT of the Owners.

4. I further acknowledge and agree:

(a) That the Activities are very dangerous, exposing participants to many risks and hazards, some of which are inherent in the very nature of the sport itself, others which result from NEGLIGENCE OR FAULT on the part of the persons involved in preparing and organizing or staging the Activities;

(b) That, as a result of the abovementioned risks and hazards, I as a participant in the Activities may suffer personal injury, disability or even death, as well as property damage and/or loss;

(c) That some of the abovementioned risks and hazards are foreseeable but others are not;

(d) That I nevertheless freely and voluntarily assume all the abovementioned risks and hazards and that, accordingly, my use of the facilities while Participating in any of the Activities shall be entirely at my own risk;

(e) That I understand that the Owners assume no responsibility or liability whatsoever for my safety while I am Participating in any of the Activities;

(f) That I am in appropriate physical condition to Participate in the Activities, and have no illness, impairment, condition, ailment, injury, sickness or disability which would or might increase the risk to me of the Activities;

(g) There may not be prompt access to medical assistance or treatment when participating in the Activities, and I assume and accept any risk relating to the access to medical assistance or treatment or lack thereof;

(h) That I have reached the age of majority (18);

(i) That I have carefully read and fully understand this COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK, and that I am freely and voluntarily executing same;

(j) That I understand that by signing this COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK, I will be forever precluded from suing or otherwise claiming against the Owners for any loss or damage connected with any property loss, personal injury, disability or death I may sustain while Participating in any of the Activities whether or not such loss or injury is caused solely or partly by the NEGLIGENCE OR FAULT of the Owners.

(k) That I understand that the Owners will not permit me to participate in the Activities now or in the future unless I sign the COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK and that this COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OF RISK applies to all of the Activities, whether occurring in the near or distant future and that the terms of this Agreement need not be brought to my attention each time I am Participating in any of the Activities in order to be effective;

(l) That this COMPLETE RELEASE, WAIVER OF CLAIM AND ASSUMPTION OR RISK is binding on myself, my heirs, my executors, administrators, personal representatives and assigns.

**EDMONTON KNIGHTS OF COLUMBUS HOCKEY ASSOCIATION
WAIVER, RELEASE AND INDEMNITY AGREEMENT**

IMPORTANT: PLEASE READ CAREFULLY BEFORE SIGNING

This document will affect your legal rights and liabilities, including the right to sue and recover damages for injury.

IN CONSIDERATION of the permission to use the Knights of Columbus Hockey Association Arena property for ice hockey I hereby agree:

1. TO ACCEPT ALL PHYSICAL AND LEGAL RISKS in connection with my use of the Knights of Columbus Hockey Association Arena
2. TO RELEASE, WAIVE AND FOREVER DISCHARGE the Edmonton Knights of Columbus Hockey Association, (including all it's employees, servants, licensees and agents, including volunteer worker(s) from any and all claims or liability in tort, contract, equity or under any statute or law for any injury, death, loss or damage to my person or property that I, or my heirs, estate, executor, administrators, successors or assigns may have arising by reason of my participation, whether as a spectator or participant in ice hockey or use of the K of C Arena or due to any act whatsoever, including (but not limited to) negligence in the part of the Knights of Columbus Hockey Association (including all its employee, servants, licensees and agents, including volunteer workers; and
3. TO HOLD AND SAVE HARMLESS and agree to indemnify the Knights of Columbus Hockey Association (including all its employees, servants, licensees and agents, including volunteer workers) from any and all liability incurred by any or all of them arising as a result of, or in any way connected with my participation in ice hockey or use of the Knights of Columbus Hockey Arena notwithstanding that such liability, actions, claims, causes of action, or demands may have been cause or contributed to by the negligence of the Knights of Columbus Hockey Association (including all its employees, servants licensees and agents, including volunteer workers.

I UNDERSTAND THAT the Knights of Columbus Hockey Association will not permit me to use the Knights of Columbus Hockey Arena property or participants in ice hockey unless I sign this Waiver, Release and Indemnity Agreement and that this Waiver, Release and Indemnity Agreement will apply to all of my subsequent participation in ice hockey and the use of the Knights of Columbus Hockey Arena whether occurring in the near or distant future and that the terms of this waiver, Release and Indemnity Agreement need not be brought to my attention each time I participate in ice hockey or use the Knights of Columbus Hockey Arena in order to be effective.

I HEREBY ACKNOWLEDGE THAT I have carefully read this Waiver, Release and Indemnity Agreement, the terms of which are contractual and not a mere recital, and that I am aware of and do understand the contents thereof and that I am executing the same as my own free act. I have had an opportunity to consult a lawyer prior to executing this Waiver, Release and Indemnity Agreement I agree that the terms of the Release shall be binding upon me, my heirs, executors, administrators and assigns.
