10.2 Business arising from the minutes

10.2.1 DMHA Fundraising

- Fundraising ideas for the next DMHA season were discussed as follows:

Golf Tournament

- Golf tournament will be held September 8, 2013 at the Devon Golf Course.
- Entry fee for tournament will be \$125 per person including breakfast, steak dinner and one drink ticket.
- DMHA parents bringing four entries to this tournament, at the \$125 entry fee, will have their \$100 fundraising fee commitment completed.
- Stephanie Cartier will take the lead on this fundraiser and report further additional details to the executive.

3 On 3 Hockey Tournament – Street Hockey

- A 3 on 3 Street Hockey Tournament will be held sometime in April 2014 – “HOCKEY DAY IN DEVON”.
- Ideally holding the Awards Presentation directly after the tournament.
- There will be a barbecue with hot dogs and hamburgers, similar to a tail gate party.

- Remax will provide a bouncy house for the younger children at no cost to our organization.
- United Cycle will provide shooter tutors for the day.
- Start this idea with the new DMHA Executive that is voted in June 2013.
- Fundraising will include:
 - \$50 per family for the DMHA Dance.
 - \$60 per child to a maximum of 2 children for the raffle tickets.
 - \$100 per child to a maximum of 2 children for a fundraiser (possible options).
- The executive discussed the gross revenue from each DMHA home tournament. The funds are substantially high, in some cases teams are having difficulty using up the funds within the hockey season. It was noted that a small portion of these funds coming back to the organization would help out significantly.
- **Motion** by Mike VantHoff that 20% of the gross revenue from each DMHA home tournament will be paid back to the DMHA.
