Requirements to Determine Whether Applicant and His/Her Family Qualify

In order for A4K to qualify as a registered charity, all beneficiaries of funding must meet very strict requirements. As such, in order to meet these requirements, all individuals must be classified as “financially disadvantaged”. Further, the use of funds must be for the purpose of paying entry level athletic fees for participation in specific sports recognized by A4K. A complete description of the A4K Funding Guidelines is available on www.a4k.ca.

Funds cannot be used for the purchase of the following:

- athletic equipment, uniform fees or deposits, field/ice rental costs
- sports camps, private instruction
- rep team fees (including tryout fees)
- activities not recognized by A4K (e.g. dance, cheerleading, etc.)
